INFORMATION SHEET

Visiting a clinical department - this is one of the entry requirements for Diagnostic Radiography. This completed form will be considered as part of the application. It is not compulsory but is strongly advised.

The candidate must have pre-arranged the visit with a member of the Clinical Liaison Team in the Imaging department.

Before he/she will be allowed to visit the clinical department he/she must fill in the attached form and obtain a letter of introduction signed by his/her current course tutor or suitable professional (e.g. family doctor, teacher, solicitor etc...). He/she must take one form of formal photo identification (e.g. passport, driving licence) with him/her to the Department on the day of the visit, if not he/she will be turned away. If he/she is under 17 years of age at the time of the visit, his/her experience may be limited due to the regulations regarding radiation protection measures.
