

Exemptions from the Standard Assessment Regulations

All validated awards are expected to comply with the Standard Assessment Regulations. Some courses and modules require exemption from some of those regulations, usually to meet Professional, Statutory or Regulatory Body requirements. The University has approved exemptions to the Standard Assessment Regulations for the courses listed in this document. Exemptions are listed by course under each College and School/Institute and applies to all versions of courses and modules.

End Point Assessments (EPA) are not eligible for compensation or repeat study. Students are only permitted the maximum attempts as per the assessment plan on the Skills England website.

Where this is not detailed in the assessment plan a maximum of 2 attempts (e.g, submission, viva) is then permitted at the EPA. For more information contact the academic team.
