This is to cover costs for any medical treatment whilst in the UK. Students applying for visas for longer than six months will be asked to pay an Immigration Health Surcharge to cover costs for any medical treatment during their time in the UK as part of the visa application process. If you are coming to the UK as a full-time higher education student and you have a European Health Insurance Card (EHIC) which has been issued in an EU country after 1 January 2021, you may be able to apply for a refund of your Immigration Health Surcharge fee. Applicants from some countries are required to have a tuberculosis (TB) test if they are coming to the UK for more than six months.
